

Kumamoto University Health Life Science S-HIGO Professional Fellowship Program

Application Guidelines for AY2021

Kumamoto University's Graduate School of Medical Sciences, Graduate School of Health Sciences and Graduate School of Pharmaceutical Sciences were selected by the Ministry of Education, Culture, Sports, Science and Technology (MEXT) for the "University Fellowship Establishment Project for the Creation of Science and Technology Innovation". With that support, a new fellowship program "Health Life Science S-HIGO Professional Training Fellowship (S-HIGO Fellowship)" has been started which will support students in Doctoral (PhD) courses by creating an environment in which students can devote themselves to their research and by helping to secure a career path after graduation. This fellowship support program aims to motivate students to enter in doctoral courses and it will offer advanced courses to nurture human resources with advanced research abilities.

Kumamoto University was previously selected for MEXT's Program for Leading Graduate Schools in 2012 and is actively involved in nurturing future health life science leaders through Health life science: Interdisciplinary and Glocal Oriented (HIGO) Program in close collaboration with governmental and business organizations.

The newly launched S-HIGO Fellowship Program will inherit the unique elements of the HIGO program and aims to produce doctoral course graduates who have advanced research capabilities in health and life sciences along with interdisciplinary mindset and practical skills.

1. Number of Students Accepted for Admission

※ Based on the selection results, if there are not sufficient eligible candidates in one graduate school, number of selected candidates from another graduate school may be increased.

2. Eligibility for Application

Students who fall under all of following categories (1) to (5) can apply for the S-HIGO Fellowship support. However, this excludes full-time employees* and students who have taken a leave or repeated a school year in the year of application.

- (1) Students who are enrolled in the 1st year of 3-year doctoral course or 1st or 2nd year of 4-year doctoral course at Graduate Schools of Medical Sciences, Pharmaceutical Sciences or Health Sciences in April 1, 2021.
- (2) Students who are of following age in April 1, 2021. However, this limit will exclude those who have experienced childbirth or child care.

Grade	Age requirement
1 st year student of 3-year doctoral course or 2 nd year student of 4-year doctoral course	Under 30 years old (Under 33 years old for those who were involved in clinical training)
1 st year student of 4-year doctoral course	Under 29 years old (Under 32 years old for those who were involved in clinical training)

- (3) Students who are not supported by JSPS special research fellowship or MEXT scholarship or foreign students who are not supported by the scholarship programs of their home country
- (4) Students who have never received a disciplinary action based on the school regulations, etc.
- (5) Students who can take the courses (S-HIGO Professional Program Course) provided by the Graduate Schools of Medical Sciences, Pharmaceutical Sciences and Health Sciences throughout the duration of the fellowship support.

*Full-time employee refers to (1) those who have a job (those who are currently in a job that earns salary, wages, remuneration, and other ordinary income), (2) those who have retired from a job that provided salaries, wages, remuneration, and other ordinary income and (3) a housewife / househusband.

For example, those who have graduated from School of Medicine or School of Dentistry and worked as clinical trainee for more years than required by Medical Practitioners' Act / Dental Practitioners' Law or worked full time employee will be considered as full-time employees.

If you are uncertain whether your experience will be counted as full-time employee or not, please contact the S-HIGO Fellowship Program Office.

3. Support Amounts

Students selected for S-HIGO Fellowship will receive (1) Research dedication stipend and (2) Research grant for the standard course completion period of 3-year doctoral course or 4-year doctoral course.

- (1) Research dedication stipend: 1,800,000 JPY/year (150,000 JPY/month)
- (2) Research grant : 200,000 JPY/year

However, if the payment of research dedication stipend starts or ends at the middle of a particular month, the amount of the payment for that month will be determined by the university.

We are currently considering of providing tuition fee support to fellowship recipients as a separate support from the fellowship.

Basically, tuition fee support will be provided to students who first apply for tuition fee exemption and Kumamoto University Graduate School Doctoral Course Scholarship Program (KDS) and are not permitted for exception. The total support will be equivalent to the half of annual tuition fee. However, for the AY2021 as the deadline for application for fee exception was April 1, we are planning to support even if above requirements are not met.

The details availability/unavailability this specific support will be announced as soon as decided by university.

4. Obligations of Fellowship Recipients

Students receiving the S-HIGO Fellowship must comply with the following terms. If any students violate these

terms, he/she might be suspended from receiving the fellowship.

- (1) Students should focus on their research activities.
- (2) Students should attend courses on research ethics and compliance organized by the program director.
- (3) Students should get confirmation of enrollment every month.
- (4) Students should submit a research plan and a research report every year to the program director.
- (5) Students should take the courses (S-HIGO Professional Program courses) provided by the Graduate Schools of Medical Sciences, Pharmaceutical Sciences and Health Sciences throughout the duration of the fellowship support.

5. Application Procedures

(1) Application Documents

- 1) Application form for S-HIGO fellowship program
- 2) Research plan
- 3) Written statement of reasons for application

< Important points >

- In general, the contents of application documents cannot be changed after submission.
- Application documents will not be returned to applicants.
- Applicants who make false statements in the application documents will be disqualified from taking the selection examination or will be disqualified to receive the fellowship even after selection.

(2) Application Period

From April 7, 2021 (Wed.) till April 19, 2021 (Mon.) 17:00

(3) Application Process

Application documents can directly be submitted or sent by postal mail (including inter-university postal service) to S-HIGO Fellowship Program Office (HIGO Program Office).

6. Selection Procedures and Notification of Results

- (1) Selection will be based on the English Score (external English language test score submitted during admission to doctoral course or external English language test score taken during the entrance examination of doctoral course or the external English language test score taken during the time of S-HIGO Fellowship selection examination), evaluation of application documents and evaluation interview.

Evaluation interview will be based on the questions related to career vision, reasons for application, research activities till the time of interview and future research plans.

9:00~11:20 English language test (TOEFL-ITP)*

12:30~ Evaluation interview (about 20 min. per student)

*English language test (TOEFL-ITP) will be conducted only for those students who did not submit the external English language test score from any valid test before application to doctoral course and did not take external English language test during the entrance examination of doctoral course.

【Venue】 School of Medicine, Kumamoto University (Kumamoto city, Chuo Ku, Honjo 1-1-1)

- (2) The selection results will be notified around late May, 2021.

7. Handling of Personal Information

- (1) Personal information contained in the application documents will be used for selection of fellowship recipients and other purposes related to the fellowship program.
- (2) Personal information such as test results used for the selection of fellowship recipients will be used for the compilation and analysis of selection results and also for the investigation and analysis of selection method.
- (3) For carrying out the above (1) and (2) operations, some operations may be outsourced to an external business form. In that case, all or part of the acquired personal information will be provided to external business form after making an appropriate contract for careful handling of personal information.

8. Orientation for Fellowship Program

Orientation programs for interested students will be organized in following time schedule and venues. It can also be attained through ZOOM and the recorded video will be later uploaded to University Moodle.
